1. Welcome and Introductions

Woody Woods called the meeting to order at 2:30.

2. Approval of Agenda

Terry Seiffert moved to approve the Agenda. Pam Ask seconded. Motion passed.

3. Approval of Minutes

Nick Pancheau moved to approve the minutes of the May 20th meeting. Mike Ariztia seconded. Motion passed.

4. Update

BSED provided updates on the following item:

Extension of the sewer boundary to include the TEDD Study Area under LWSD's existing Wastewater Service Agreement with the City. Discussions have continued with the City and have shown some progress. We are working to develop a proposal that will be acceptable to the City and the TEDD property owners but will not including Waivers of the Right to Protest Annexation. We are meeting June 18 to work out some details. The proposal will likely include an increased surcharge on sewer service for the TEDD, restrictions on LWSD using Heights Water for possible future water needs, and an agreement between the County and City regarding handling of future development and annexation along the City-County fringe.

5. FY2021 Work Plan/Budget

The Annual Work Plan was discussed. A section was added outlining the work done and other important information from the past year. Those items included:

- Completion of the 2019 Strategic Plan
- Continuing discussions with the City of Billings on extension of LWSD sewer boundary
- Floodplain issues 1D vs 2D mapping
- The effects of COVID-19
- The Billings Bypass project progress

FY2021 Project Priorities were listed as:

- Resolve the Wastewater Service issue
- Planning for extension of Water/Sewer Infrastructure under Johnson Lane Interchange
- Remapping of Flood Hazard Area
- Coordinate/facilitate development efforts by property owners
- Coordination with MDT on Bypass project
- Continued coordination with railroads
- Marketing and recruitment of the TEDD to industrial developers

The Board suggested two additions to the Work Plan:

- Advocate for an acceptable plan for access to North Frontage Road from the planned Johnson Lane Interchange
- Develop a comparison of timeline and cost between sewer service via LWSD and a package wastewater system.
